Subject: FIR for Forceful Taking and Looting of Vehicle During Night Travel

Respected Sir

I, **Sunil Prasad Sahu** son of Late Ramawatar Prasad Sahu, residing at Mantripukhri would like to file a First Information Report (FIR) regarding an incident of forceful vehicle looting that occurred during my travel last night. The details of the incident are as follows:

3. Location of Incident: Nagamapal, Near Sangai Hotel

Details of the Incident:

Last night, I Was attending a meeting of the IOCL, Employee Union , which ended around 11.00 PM. After the meeting I got into my vehicle parked outside, and started the car to return home. As soon as I started the vehicle , I was approached by two unidentified men(who initially claimed to be AT individuals) and got into the vehicle and took the steering, drove towards Mantripukhri. After reaching my residence place, they (one of whom claimed to be an Sub-Inspector, posted at Heingang PS, also wearing khaki, with red hat on head) told to leave the vehicle with them and the vehicle will be returned in the morning to me.

When I told them that I need my vehicle in the early morning for my duty, at the Airport, they told that they have to report to the Police Headquarter and they also took an id (Aadhar card) from me and told that they would return the vehicle at around 10.am in the morning . Having apprehensions about their identity and motive, and no one to witness or help, I had no other choice than to agree to them.

In the morning I tried contacting the Heingang PS, for reporting and for Help , I got to know that no such SI, exists .

Description of the Perpetrators:

Appearance and Clothing: One person in Khaki(resembling police uniform) and the other in Camouflage

Having apprehensions about possible misuse, I request you to kindly register my FIR and take immediate action to investigate this matter. I hope for the prompt recovery of my vehicle and the apprehension of the culprits involved in this crime.
