

I am directed to request you to lodge a complaint against Shri Dr. S. Indra Singh S/o (L) S. Gourachand Singh, HaorreibiMayaiLeikai, P.O. & P.S. Wangoi, Imphal West District, Manipur on the following grounds :


- (i) Dr. S. IndraSingh, has published news report in some local daily alleging that the Department(Vety& AH) staff has forged the signature of the Hon'ble Chief Minister by staff of the Vety& AH Dept. This has tarnished the image and reputation of the Dept and its staffs in the public and moreover the public losing the confidence of the Govt. The Newspaper on which the said false information was published were (a) Manipur Mail Dated 08 May 2024 2. (b) Naharol Thoudang Dated 08 May 2024 and other daily Manipuri newspaper of the state.
- (ii) Further , Dr.S.Indra Singh , using the name of his wife S. Bino Devi , published in the Echel Newspaper dated 16<sup>th</sup> April 2024 , that the Joint Secretary of the Vety & AH Dept Shri Ksh. Siddharth and Section Officer of the same Dept Shri. Md. Rausan Ali , are acting as judge for quoting certain judgments while passing order of the Dept which went against him , in which he published the name and addresses of the said two officer and pleading to others to interfere in the said case for him, which seriously put in danger physical security and infringes to the privacy of the two officers. In the same newspaper article the it was also mentioned that if anything happens to him then the said officer should take the full responsibility which tantamount to intimidation and threat.


