Officer-in-charge IMPHAL POLICE STATION Imphal West Dist., Manipur Today i.e. 03/06/2024 at 11.30 pm, received an information that on the same date at around 11.25 pm, one object suspected to be hand Grenade was exploded in front of the residential gate of one Laishram Saratchandra Singh (57) S/o (L) L. Irabot Singh of Sagolband Nepra Menjor Mamang Leirak, Imphal West. The bomb might have been hurled by unknown miscreants with an intent to cause death of human life and damage of properties. As a result of which the main iron gate and one Ecco Van were partly damaged, however there was no casualty.

Hence, a suo-motu case under FIR No. 320(06)2024 IPS u/s 307/427/506/34 IPC & 3 Expl. Subs. Act has been registered against the unknown culprit(s) for investigation.
