Subject :- Submission of enquiry report.

Sir,

As endorsed, I have visited the residence of the complainant and conducted an enquiry on the application filed by Ksh. Sarjulata Devi W/O Gagandeep Singh of Thangal Bazar, Imphal which states that on 9/4/2023 at about 12 noon, the following persons namely 1) Manmeet Singh Arora 60 yrs, and 2) Simranjeet Singh Arora, 26 years, all are of Thangal Bazar along with two unknown persons came to inside her house located at Thangal Bazar and beaten her and her husband namely Gagandeep by using deadly weapons like stone, stick etc. They also kicked to the chest of the complainant and private part and even pulled her hair down and snatched and carried away a sum of Rs 50000/- and a gold chain of her husband of Rs. 4.5 tula, valued about Rs 2,50,000/-.

In the course of enquiry, examined the complainant very minutely and carefully. Further enquiry reveals that the complainant and the opposite sides (Manmeet Singh Arora & Simranjeet Singh Arora) are neighbours. On that very day, Manmeet Singh Arora 60 yrs, and his son - Simranjeet Singh Arora, 26 years, all are of Thangal Bazar along with two unknown persons came inside the complainant's house through back door and assaulted the complainant and her husband by using deadly weapons like iron rod and brick. Under the influence of Manmeet Singh, his son Simranjeet also kick to the chest of the complainant and also pulled her down by holding her hair, thus outraging the modesty of a woman. The unknown two persons ran away before commission of the crime. Further, it is also learnt that after the incident, a gold chain (4.5 Tula) of her husband valued about Rs 2,50,000/- was also found missing as the complainant suspected to have snatched and carried away by the alleged parties. As a result, the complainant along with her husband received injuries on their persons and evacuated to RIMS hospital for medical treatment. Now, the tension between the parties is still in a high mood.

It is therefore, considered necessary to register a regular FIR case for proper investigation of the case as the incident attracts assault and crime against women.

Hence, the above report is submitted for kind perusal and taking further necessary action as per law.
