**Subject:-** A complaint petition against (i) Gagandeep Singh (Bedi), S/o. Sarabjit Singh (Bedi) of Thangal Bazar, Imphal West, Manipur and (ii) Ksh. Sarjulata Devi, W/o. Gagandeep Singh (Bedi) of Thangal Bazar, Imphal West, Manipur for causing grievous hurt to my son and also threatening me regarding the construction of residential structure of Mandeep Setia.

Respected Sir,

With due respect, I would like to file a complaint against the above-mentioned accused persons for causing my son grievous hurt on his neck by using keychain of the vehicle of the Accused No. (i) Gagandeep Singh (Bedi). That, I am an senior citizen and I have a shop at Thangal Bazar. That, on 09.04.2023 at around 1:00 PM, the accused persons came in front of my said shop and started verbal abuse towards me and also tried to beat me up. When my son namely Simranjeet Singh Arora tried to intervene, the said accused persons beat up my said son. The accused no. (i) tried to grabbed my son's neck and when my son



defended himself, the accused no. (i) used a keychain with the key of a vehicle and grievously injured my son on his neck. The accused no. (ii) also scratched at my son and also pulled his beard. Afterwards, my son was rushed to RIMS Hospital, Imphal and was treated for his injuries on the same day. That, before the said incident the said accused persons also have threatened to beat me up frequently and even chased me with dangerous weapons and threatened me in connection with my moral support for the construction of residential structure of Mandeep Setia, my brother-in-law. Thereafter, the said accused persons have always tried to harm me one way or other whenever they see me.

It is, therefore, prayed to kindly take up necessary legal actions against the said accused persons in the interest of justice.
