It is also found that, the said person Malem Thongam, Transgender Social Activist Manipur had earlier protested (Hunger Strike) at Western Gate, Kangla and Shamu Makhong, it refers to GD Entry No. 25/City-PS/2024 dtd. 6/03/2024 & GD Entry No. 24/City-PS/2024 dtd. 8/03/2024 respectively.

Hence a suo-motu case under FIR No. 41(04)2024 City-PS. U/s. 188/186 IPC has been registered for investigation
