Subject: - Report.



Sir,

I have the honour to state that today i.e. 17/05/2024 at about 11:00 am on receipt of reliable information from our own sources about the presence of some active cadres of PREPAK organisation in and around Thangal Bazar area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Thangal Bazar. During that, one unknown person was seen standing near White house, Thangal Bazar in a very suspicious manner. Due to his suspicious nature, he was detained for spot checking and verification. On spot body search, one POCO C55 mobile handset along with two SIM cards i.e., (i) one Jio SIM card bearing ph. no. 9366743918 as disclosed by him and (ii) one Airtel SIM card bearing ph. no. 7085980825 as disclosed by him was recovered from his possession.

On spot verification, he identified himself as Konthoujam Kumar Singh (46 yrs.) S/o. (L) K. Khoidum Singh of Konthoujam Mamang Leikai. During preliminary verification, he disclosed that he is an active member of PREPAK organisation and started working for the said organisation since first week of May, 2024 under the command of s/s commander Nongdrenkhomba of PREPAK organisation. Further, he disclosed that under the instruction of his commander, he along with his 2 (two) associates namely Ankur Mahawar of Thangal Bazar (owner of The Ashokumar Mahawar shop, Allu Gali) and Naveen Mahawar of Thangal Bazar (owner of The Ramavatar Ishwarlal shop, near White house, Thangal Bazar) had made monetary demands from some shops located at Thangal bazar area. Hence, he was arrested from the spot at 11:30 am and the above recovered item was seized at 11:40 am from his possession by observing formalities.

Immediately, our team along with the arrestee rushed to The Ashokumar Mahawar shop located at Allu Gali and successfully detained Ankur Mahawar (40 yrs.) S/o. Mahendra Mahawar of Thangal Bazar as identified by the arrestee. On spot body search, one iPhone 13 mobile handset along with two SIM cards i.e., (i) one Airtel SIM card bearing ph. no. 8974559252 as disclosed by him and (ii) one Jio SIM card bearing ph. no. 9774095489 as disclosed by him and a sum of Rs. 1,55,000/- (rupees one lakh fifty five thousand only) were recovered from his possession. On preliminary verification, he disclosed that he is an active member of PREPAK organisation and started working for the said organisation since first week of May, 2024 under the command of s/s commander Konthoujam Kumar Singh of PREPAK organisation. Further he disclosed that under the instruction of his commander, he had collected a sum of Rs. 1,55,000/- (the above recovered amount) from some shops located near Allu Gali, Thangal bazar. Hence, he was arrested from the spot at 12:00 pm and the above recovered items were seized at 12:10 pm from his possession by observing formalities.



Immediately, our team along with the arrestees rushed to The Naveen Mahawar shop located at The Ramavatar Ishwarlal, near White house, Thangal Bazar and successfully detained Naveen Mahawar (48 yrs.) S/o. Ishwarlal Mahawar of Thangal Bazar as identified by the arrestees. On spot body search, one iPhone 6 mobile handset along with one Airtel SIM card bearing ph. no. 9862144919 as disclosed by him and a sum of Rs. 35,000/- (rupees thirty five thousand only) were recovered from his possession. On preliminary verification, he disclosed that he is an active member of PREPAK organisation and started working for the said organisation since first week of May, 2024 under the command of s/s commander Konthoujam Kumar Singh of PREPAK organisation. Further he disclosed that under the instruction of his commander, he had collected a sum of Rs. 35,000/- (the above recovered amount) from some shops located near White house, Thangal bazar. Hence, he was arrested from the spot at 12:40 pm and the above recovered items were seized at 12:50 pm from his possession by observing formalities.

Hence, the arrested persons along with the seized items are handed over to you for taking further necessary legal action against them.
