Sir.



With due respect, I have the honour to state that I was a permanent resident of Moreh Ward No. 4 under patta no.4029 dag no. 3394 registered in my name, that on 3rd May, 2023, ethnic clashes erupted in most of the Kuki dominated areas in Manipur between Meitei and Kuki community. In the evening, I took refuge in the Hechin's Budhist temple in the neighboring Country Myanmar. Then the armed Kuki militants with deadly weapons and sophisticated arms stormed the Meitei dominated areas in Moreh and started burning and destruction of my house at Moreh Premnagar ward no. 4. My house were looted and destroyed by the armed Kuki militants. All my properties including furniture, utensils, electronic devices, jewellery and cash were at loss. The estimated loss of my properties including my house will be around Rs.6500000 (Sixty five Lakhs only). At present I am staying at the Thongju Kendra Relief Camp at Ideal Girls College, Akampat since 22nd Feb 2024. My sincere apology for this delay in filing FIR. The reason for delay was that I in fear for my wife & children flee to Guwahati after the 5th Assam Riffle rescued us on 19th Dec 2023, as my wife is from other community. We came back to Imphal after making sure we are safe. My sincere apology for this delay in filing the FIR.

In this regard, I would like to lodge this First Information Report for your kind perusal and acceptance of this FIR for further necessary action.
