Sir,

With due respect, I have the honour to state that I was a permanent resident of Moreh Ward No. 4 under patta no.4448 dag no. 477 registered in my name, that on 3<sup>rd</sup> May, 2023, ethnic clashes erupted in most of the Kuki dominated areas in Manipur between Meitei and Kuki community. In the evening, I took refuge in the Hechin's Budhist temple in the neighboring Country Myanmar. Then the armed Kuki militants with deadly weapons and sophisticated arms stormed the Meitei dominated areas in Moreh and started burning and destruction of my house at Moreh Turelwangma ward no.7. My house were looted and destroyed by the armed Kuki militants. All my properties including furniture, utensils, electronic devices, jewellery and cash were at loss. The estimated loss of my properties including my house will be around Rs.4000000 (Forty Lakhs only). At present I am staying at the Thongju Kendra Relief Camp at Ideal Girls College, Akampat since 22<sup>nd</sup> Dec 2023 after the 5<sup>th</sup> Assam Riffle rescued us. My sincere apology for this delay in filing FIR. The reason for delay was that my mother in law passed away who lived in Assam, I had to move in there on 28<sup>th</sup> Dec 2023. I came back to the relief camp after the burial and sorat of my mother in law on 22<sup>nd</sup> Feb 2024.

In this regard, I would like to lodge this First Information Report for your kind perusal and acceptance of this FIR for further necessary action.
