Subject: - Missing report of 2 (two) departmental vehicles from the Office of Mechanical & Electrical Division, PHED, Manipur.

Sir,

I, the undersigned would like to lay down a few words for your kind consideration and necessary action that I have taken the charge of Mechanical & Electrical Division PHED, Manipur on 7th February 2024. From 9th Feb onwards checking and verifying technically started for all vehicles which stands off road for any development required to be functional again, starting from heavy vehicle such as JCB excavator, Tata truck, Pickup truck and secondly all the electrical equipment such as generators, compressor both air and hydraulic, hydraulic jack, welding machine etc. Thirdly, the light vehicle such as Bolero, Scorpio, Gypsy etc both on-road (on-road are vehicles allotted to the concerned departmental officials) and Off-road lying at the department garage has been checked on 23rd & 26th Feb 2024 and it was found that 2(two) vehicles namely (1) Maruti Gypsy bearing registration no. MN-06L-1204 (2) Maruti Gypsy bearing registration no. MN-01X-0243 has been missing so, after enquiring the staffs it came to the light that the two vehicles were taken away forcibly by some unknown miscreants and no report of this matter were reported to the concerned police station timely by the preceding Executive Engineer out of apprehension due to the present situation.

Till date the whereabouts of the two vehicles is unknown, I earnestly request you to please trace the missing vehicles.
