Subject: - Report.

Sir,

I have the honour to state that today i.e. 02/03/2024 at about 01:30 pm based on an intelligence provided by 4 AR about the presence of some active cadres of KCP organization in and around Khuman Lampak area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector Somayo R. Shimray and myself under the command of Shri RK. Eden Singh, MPS Dy. SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Tangkhul Avenue, opposite to ISBT, Khuman Lampak. During that, two unknown persons were found standing near a shop located at Tangkhul Avenue, opposite to ISBT, Khuman Lampak in a very suspicious manner. Due to their suspicious nature, they were detained for spot verification/checking. During spot verification, they identified themselves as (i) Khoinaijam Robertson Singh (23 yrs.) S/o. (L) Kh. Tolen Singh of Chingmeirong Maning Leikai and (ii) Khaidem Naoba Meitei (20 yrs.) S/o. Khaidem Raghmani Meitei of Sugnu Turel Wangma a/p Lamlai Mayai Leikai.

On spot body search of Khoinaijam Robertson Singh, 1 (one) POCO mobile handset model no. M2010J19CI along with two SIM cards i.e., (i) one Jio SIM card bearing ph. no. 9366290862 (as disclosed by him) and (ii) one Airtel SIM card bearing ph. no. 6909436597 (as disclosed by him) was recovered from his possession. On spot body search of Khaidem Naoba Meitei, 1 (one) Nokia mobile handset model no. TA-1575 along with one Airtel SIM card bearing ph. no. 918730982103 (as disclosed by him) and one wallet brown in colour containing three slips of paper with the words "K.C.P Noyon 8730982103 Khelemba Meitei", one slip of paper mentioning names of individuals/shops and a sum of Rs. 10/- (rupees ten only) were recovered from his possession.

On further verification, they disclosed that they are active members of KCP(Noyon) organization and presently working under the command of one s/s Commander Rojit (Finance) (Ph. no. +919366603861) of KCP(Noyon) organization from Thoubal. They disclosed that the slips mentioned above contain names of individuals/shops to be extorted and the name of their leader with contact number for disbursal in lieu of extortion letter. They also disclosed that they used one Honda Activa red in colour bearing regd. no. MN01C 7157 in the crime (driven by Khoinaijam Robertson Singh) and the same was found parked near the spot and was also recovered.

Hence, they were arrested at the spot at 02:10 pm and 02:20 pm and the above recovered articles were seized from their possession at 02:15 pm and 02:25 pm from the spot respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
