Today, i.e. 5/3/2024 at 7:15 am, found publication in the Sangai Express Newspaper of dated 05/03/2024 that on 05/03/2024 at about 1:30 am, S/S Maj. Boycha (CO of Pakhangba Bn. UNLF) and his party have kidnapped 3 unknown armed miscreants along with 9 arms and many ammunitions. The three unknown armed persons of "Khun Ngakpa Volunteers" are identified as 1) Khwairakpam Kumar (40) yrs S/o Kh. Samu of Thanga Oinam A/p Lamphel Yaipha Leikai, 2) Nongthombam Goroba (38) yrs S/o Late N. Nongyai of Nagamapal Paonam Leikai A/p National Game Village, Zone-IV and 3) Sougrakpam Hemjit (36) yrs S/o S. Rajen of Ithai Mamang Leikai A/p Lamphel from Langol area. Later they were handed to their relative after proper counseling.

Hence, a Suo-Motu case under FIR No. 120(3)2024 LPS u/s 365/384/34-IPC, 25(1-B) Arms Act & 20 UA(P)Act.
