Subject: - Report.

Sir,

I have the honour to state that today i.e. 05/03/2024 at about 02.00 pm on receipt of reliable information from 4 AR and further corroborated from our own sources about the presence of some active cadres of KCP organization in and around Lamphel Super Market area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector Somayo R. Shimray and myself under the command of Shri RK. Eden Singh, MPS Dy. SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Lamphel Super Market area. During that, one unknown person was standing near Rachel Beauty Parlour located at Lamphel Super Market in a very suspicious manner. Due to his suspicious nature, he was detained for spot verification/checking. During spot verification, he identified himself as Thokchom Iboyaima Singh (42 yrs.) @ Boyai S/o. (L) Th. Iboton Singh of Kyamgei Awang Leikai, Imphal East.

On spot body search, the following items were recovered from his possession:-

- (i) 3 (three) mobile handsets i.e. (a) one Redmi 9 mobile handset along with one Airtel SIM card bearing ph. no. 9233688285 (as disclosed by him), (b) one Nokia mobile handset model no. TA-1575 with one Airtel SIM card bearing ph. no. 7629837677 (as disclosed by him) and (c) one Cellecor C9 mobile handset with one Airtel SIM card bearing ph. no. 8731015689 (as disclosed by him) and
- One wallet blue in colour containing, (a) a sum of Rs. 8200/- (Rupees eight thousand and two (ii) hundred only) and (b) one Aadhaar Card.

During preliminary verification, he disclosed that he is an active member of KCP (Lamyanba Khuman) organisation and joined the said organisation through one Mayanglambam Dhanabir Singh from Kyamgei Awang Leikai of KCP (Lamyanba Khuman) organisation in September, 2023 and presently working for the said organisation under the command of the above mentioned s/s commander Mayanglambam Dhanabir Singh (Ph. No. 873083597) and he along with his commander made monetary demands to several businessmen and general public etc. located in and around Imphal area. He further disclosed that he used one Maruti Alto Car while making monetary demands and as pointed out by him the said Maruti Alto Car Silver in colour bearing registration number MN01K 3388 was found parked near the spot and the same was later recovered.

Hence, he was arrested from the spot at 02:40 pm and the above recovered items were seized at 02:50 pm by observing formalities.

Hence, the arrested person along with the seized items is handed over to you for taking further necessary legal action against him.
