Subject: - Report.

Sir,

I have the honour to state that today i.e. 06/03/2024 at about 12:40 pm on receipt of reliable information from 4 AR and further corroborated from our own sources about the presence of some active cadres of KCP organisation in and around Changangei area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector Somayo R. Shimray and myself under the command of Shri RK. Eden Singh, MPS Dy. SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Changangei near Blossom School. During that, two unknown persons were found standing near the gate of Blossom School at Changangei Uchekon in a very suspicious manner. Due to their suspicious nature, they were detained for spot verification/checking. During spot verification, they identified themselves as (i) Yumnam Arvind Singh (21 yrs) @ Mangangcha S/o. Y. Budhi Singh of Wahengkhuman Mayai Leikai, Nambol and (ii) Oinam Rakesh Meitei (20 yrs) @ Chingshangamba (L) O. Chandra Meitei of Wahengkhuman Mayai Leikai, Nambol.

On spot body search Yumnam Arvind @ Mangangcha, 1 (one) Redmi Note 7S mobile handset along with one JIO SIM card bearing ph. no. 7005905307 (as disclosed by him) and one wallet black in colour containing a sum of Rs. 1,790/- (Rupees one thousand seven hundred and ninety only) and one Aadhaar card recorded in his name were recovered from his possession. On spot body search of Oinam Rakesh Meitei @ Chingshangamba, one Redmi 9 Power mobile handset along with two Airtel SIM cards bearing ph. nos. 8798021642 and 7628986500 (as disclosed by him), one camouflage wallet containing a sum of Rs. 1,580/- (Rupees one thousand five hundred and eighty only) and one Aadhaar card recorded in his name and one vehicle key were recovered from his possession.

On further verification, they disclosed that they are active members of KCP (Taibanganba) organisation and started working for the said organisation since 5 (five) months back and presently working under the command of one s/s Section Commander of Finance Section Alex @ Ramesh @ Chingthang (Ph. no. +916909652392) from Torbung Bangla of KCP (Taibanganba) organisation which is presently working under the command of one Koireng, s/s Financial Secretary of the said organisation. They also disclosed that under the instruction of their commander, Alex @ Ramesh @ Chingthang, they have made monetary demands to schools, private hospitals and Brick farms located in and around Imphal area. They further disclosed that they used one Hyundai i20 car to carry out their party activities and as pointed out by Oinam Rakesh Meitei the said Hyundai i20 ASTA car grey in colour bearing registration number MN05J 0532 was found parked near the gate of Blossom School. On Further checking the said car, one cartoon box containing three Patka helmets was found from the trunk of the said car and one vehicle registration card of the said car (in the name of one Nongmaithem Bishorjit Singh S/o. N. Manao Singh of Sekmaijin Bazar).

Hence, Yumnam Arvind @ Mangangcha was arrested at the spot at 01:20 pm and seized the above recovered items from his possession at 01:25 pm and Oinam Rakesh Meitei @ Chingshangamba was also arrested at the spot at 01:30 pm and seized the above mentioned recovered items along with the said car, respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
