Subject :- Report on Looting, Vandalism and burning down of household items/assets. and Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, Personal No. 2003193H Rank- RFN Shri. Thangkholen Haolai of 20<sup>th</sup> Assam Rifles, aged about 48 years S/o P Haolai, Belonging to Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of Khongsai Veng, Laipham Khonou Imphal-East District, Manipur. P.O&P.S., Heingang. Lamphel.
2. That at about 3:30 pm on the 4<sup>th</sup> of may 2023, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with Meitei Mob attacked our locality . And in the process, they have looted then burnt down my house along with all my household items and assets.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.60,00,000/- ( Rupees Sixty Lakhs ) only.
4. Fortunately, my Family managed to escaped from the criminals, and now currently taking refuge at Aizawl Mizoram .
5. That, I am filing this information lately because I was at my Posting place ( Pallen 20<sup>th</sup> AR) at the time of the incident, And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
