Subject: Report on crimes of unlawful displacement, looting, vandalism and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Simte Tribe, which is a recognized tribe under the Constitution of India and residing at a rented house located at House No. 154, Lamphel, Sanakeithel Lamphelpat, P.O. & P.S- Lamphelpat & district- Imphal West, Manipur owned by namely- Th. Chaoba Singh.

That, on the 4th of May, 2023 at, around 7:30 PM, with the help of a good friend belonging to another Tribe/Community, it came to my knowledge that a group of Meetei / Meitei miscreants suspected to be members of Arambai Tenggol and the locals in and around the area broke open the door of the said allotted Quarter and in the process they have vandalized and looted my household items/ movable properties, that includes;

2) Electronics & electrical	Rs.1,20,000/-
3) Kitchen items	Rs.3,00,000/-
4) Personal belongings	Rs.1,00,000/-
5) Misc	Rs.1,50,000/-
TOTAL AMOUNT	RS.15,90,000/-

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.15,90,000/- (Rupees Fifteen Lakhs Ninety Thousand) Only, exclusive of the house.
