I am a scheduled tribe belonging to the Simte Tribe, which is a recognized tribe under the Constitution of India and residing at a rented house located at House No. 154, Lamphel, Sanakeithel Lamphelpat, P.O. & P.S- Lamphelpat & district- Imphal West, Manipur owned by namely- Th. Chaoba Singh.

That, on the 4th of May, 2023 at around 7:30 PM, with the help of a good friend helonging to another Tribe/Community, it came to my knowledge that a group of Meetei / Meitei miscreants suspected to be members of Arambai Tenggol and the locals in and around the area broke open the door of the said allotted Quarter and in the process they have vandalized and looted my household items/ movable properties, that includes;
