1. That, I **Ngamkholet Kuki** Age: 63 S/O Hemchung Kuki belongs to KUKI Community, a schedule Tribe recognized under the constitution of India. Whereby, I am a Permanent resident at **National Games Village Near KCC Church P.S: Lamphel District: Imphal West**.

2. That on **3rd May 2023 at 11 pm**, a huge contingent of **Armed radical/ Meitei, Arambai Tengoi and Meitei Iepun** attack our village and in the process looted/Vandalized and **burnt** our houses and properties.

3. That the above said criminals with there in humane activities have causes me grave mental agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous wealth estimated to be **Rs 88 Lakhs 50k**.

4. Fortunatrly, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge **T.Lailoiphai Village Churachandpur**.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
