With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Any Kuki Tribe, which is a recognized tribe under the Constitution of India and a resident of Qtr.No D-34, Type III, Langol Housing Complex, P.O. & P.S- Lamphepat & district- Imphal West, Manipur, a quarter allotted to **Mrs.Hoijaching.**

That, on the 20<sup>th</sup> of May, 2023 at around 11:30 AM, with the help of a good friend belonging to another Tribe/Community, it came to my knowledge that a group of Meitei / Meitei miscreants suspected to be members of Arambai Tenggol and the locals in and around the area broke open the door of the said allotted Quarter and in the process they have vandalized and looted my household items/ movable properties, that includes;
