- 3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be 35 lakhs only.
- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at K.Salbung Relief Centre, Churachandpur.
- So, I could not make the said report on time due to present situation which unable me to do the report.
- I, therefore, request you to register on FIR and bring justice.
