**Subject :- Report of criminal unlawful displacement, Looting, Vandalism of household items/assets & discrimination of schedule Tribe.**

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Haukhojam Samte aged about 52 years H/o Lalneikim Samte Belonging to the Paite Tribe / Community, schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a resident of National Games Village Zone 0 B 374, P.S-LAMPHEI, Imphal west, Manipur.
2. That at about 7am on the 4<sup>th</sup> of may 2023, our locality were attack by Terror group suspected to be member of the ArambaiTengol and MeeteiLeepun along with Meitei Mob with an intent to Murder and looted, Vandalized house with state forces remaining as a mute spectator to the unfolding horrendous events.
3. That, the above name terror groups came with deadly sophisticated weapon like Ak-Rifle, SLR, Machete/Sword, iron rods, with an intent to murder.
4. That, the said terror groups were shouting anti-tribal(kuki) slogans while attacking our locality, like "H Hatlo" etc meaning "kill the kukis", "kill the tribal".
5. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.95,00,000/- ( Rupees Nine five Lakhs ) only.
6. That, with no sense of security and for fear of life me and my family compelled to take shelter and refuge at Cl camp Lamphei. Fortunately, me and my family managed to escaped from the said Terror groups who try to kill alive. Thereupon we embark upon our journey towards Churachandpur seeking safety and refuge : subsequently reach Churachandpur.
7. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Head Quarter veng Churachandpur. thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
