This act is not only direct threat to the safety and security of my business but also to the lives of my staffs and me working diligently at their establishment.

Given the severity of this intimidation, I urge you to take immediate action and I look forward to your prompt response and action to ensure the safety of my employees and myself from such anti-social elements.
