Subject:- Report on Looting household items/assets, Documents and discrimination of Schedule Tribes.

Sir.

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I, Sholal Touthang aged about 62 years S/o (L) Thongkhopao Touthang Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident of Langol Gamngai Veng, Phaipijang Part-IV Imphal-West District Manipur. P.O. &P.S., Lamphel.
- 2. That on the 3rd of may 2023 at around 10:00 pm our locality at the above mentioned address was attacked by some unknown miscreants suspected to be a members of arambai tengol along with Meitei mob. So, in order to save ourself from the attack, I and my family have to run for our lives on the 4th of May 2023 at about 8:30 am, leaving behind our House, along with all our household items and belongings and took shelter at Koirengei. And in the process, some unknown miscreants from the majoritarian Community have looted our house including all our household items and belongings as well as some of our original Documents and Cash worth about Eighty Thousand. On 5 the June, 2019 at amound 5:00 P. M.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.18,00,000 (Rupees Eighteen Lakhs) only
- 4. Fortunately, I managed to escape from the Violence, and now currently taking refuge at $Molnom\ Village\ Churachandpur$.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
