

With due respect I am to report that on 04/05/2023, I along with my family escaped from our house situated at Type II/B-26, Langol Housing Complex, due to attack by Meitei miscreants along with Arambai Tenggol and Meitei Leepun and took refuge at CRPF camp, Lamphel,

That, as per reliable information on 05/05/2023 @ 10 am, our house had been broken open, and our properties had been vandalized, looted. List of the properties looted/ stolen are as below:
