Subject: Report regarding looting of properties.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I would like to inform that I had been allotted a Government Quarter - Type II, No. 12'A, RIMS, at Lamphelpat, Imphal West, PS - Lamphel. That, due to the communal clash that broke out from 3<sup>rd</sup> May, 2023, we had abandoned our government quarter for our safety and get evacuated to a safer place.

However, on 5th May, 2023, we had received information from our neighbours that on the same day at around 5:00 p.m, my residential Quarter was broke opened by unknown miscreants and all my household properties worth Rs. 9,56,000/- were looted/stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
