
That, as per reliable information on 05/05/2023 @ 10 am, our house had been broken open, and our properties had been vandalized by unknown miscreants.


The total loss is estimated to be amounting of Rs. 2,00,00,000 (Rupees Two Crores) only. Fortunately, all family members managed to escape from the criminals.
