The total loss is estimated to be amounting of Rs. 2,00,00,000 (Rupees Two Crores) only. Fortunately, all family members managed to escape from the criminals.

It is therefore, requested to kindly take up necessary legal action against the unknown culprits. Causes of delay in reporting on time is due to my displacement.
