Sub: Complain for filing an FIR against the theft of an official Vehicle of the Directorate of Education (S) from the office complex.

Sir,

It is to state that on 4<sup>rd</sup> March, 2024 at around 10.25 P.M three unknown persons entered the office campus of Directorate of Education (S), Government of Manipur by breaking the lock of the Main gate of the campus. They came in 2 (two) vehicles, a car and a Gypsy, around 10 persons were inside the car and Gypsy, and they towed away an official vehicle (Gypsy registration No. MN-01-K 7380) parked in the campus which had no front tires.

As informed by the Chowkidar who was on duty on that day, the three unknown persons entered the campus and asked for the key of the main gate from the Chowkidar on duty. The chowkidar refused to open the gate. Thereupon the said three unknown persons broke the lock of the gate and entered with 2 (two) vehicles, a car and a Gypsy, around 10 persons were inside the car and Gypsy. The vehicles had no registration number plates. They then fitted the tyre which they brought with them and towed away the official vehicle (Gypsy registration No. MN-01-K 7380). They also inspected three other official vehicles which were parked in the office campus.

In this regard, I am to request you to file an FIR and also to take further necessary action.
