I am a scheduled tribe belonging to the Vaiphei Tribe, which is a recognized tribe under the Constitution of India and a resident of Hill Side Colony, Phaipijang, Langol, P.O. & P.S.- Lamphelpat, district- Imphal West, Manipur.

That, on the 4th of May, 2023 at around 1:30 PM, a group of Meetei / Meitei miscreants suspected to be members of Arambai Tenggol, Meitei Leepun along with the local mob in and around the area attacked my vehicle, in the process they vandalised and arson/ burnt my vehicle which was parked in front of K.V. No. 1 Imphal, P.O. & P.S.- Lamphelpat, Imphal West.

That, it may also be report that the said criminal activities have cause grave mental agony and its estimated to be about Rs.2,50,000 (Rupees Two Lakhs Fifty Thousand) Only.
