With due respect I am to report that on 3/5/2023 Meitel radicals including locals of Langol attacked Kuki-Zo communities. So on 4/5/2023 I along with my family had escaped from our residence, situated at Joseph Colony, Phalpijang Langol, Imphal West, under Patta No.197 (Old) 2183 (new), to CRPF camp Lamphel, as our community was under attacked. That, from reliable information learned that some Meitel miscreants had trespassed into my Building on 4/5/2023 at about 4 pm and looted, destroyed my movable properties in my three storey building occupied by two families and burnt our kitchen cum attach storage, and lost properties are as follows:-

Mr. Thokchom Bronson (living in Kutcha house adjacent to Qtr. No. H-39, type-iii, Langol, 6. Thokchom Boray (living ner qtr. H39) 7. Mr. Naocha, (magic vehicle driver, living ner type-2 pharmacy, 8. Mr. Robert living at Qtr. No. A-28, ty-ll, Langol 9. Mr. Boney (living at B-sector 5 th line, type-li, langol and 10. Mr. Kabi (Owner of pork centre, near student variety store, Langol.

That, I belonged to Thadou Kuki tribe, which is a recognized Tribe in India

It is therefore requested to kindly take up necessary legal action, register an FIR and arrest the known and unknown culprits, for the ends of justice.

Dispur P.S had not registered FIR based on my complaint report dated 16/5/2023 and my displacement, are causes of delay in reporting on time.
