1. That, I Thanglet Khongsai Age: 68 S/O Thangjam Khongsai belong to KUKI Community, a schedule Tribe recognized under the constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) ACT, 1989. Whereby, I am a permanent resident of MT Quarter House no 6 P.S: Lamphel, District: Imphal East.

2. That on 4th May 2023 at 3pm a huge contingent of Armed radical/ Meitei, Arambai Tengol and Meitei leepun attack our village and in the process looted/Vandalized properties.

3. That the above said criminals with there in humane activities have causes me grave mental agony. Notwithstanding the fact that their unruly activities have made me great loss enormous wealth estimated to be Rs 21 Lakhs 30K.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at L.Chaljang Village Churachandpur.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
