With reference to the above cited Subject, I have the honor to report to you as below:

1. That, I Thangpao Touthang, Aged 34 S/O Jamsei Touthang belongs to KUKI Community, a schedule Tribe recognized under the constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) ACT, 1989. Whereby, I am a permanent resident of National Game Village zone - 1 B/375 P.S Lamphel, Imphal West District.

2. That on 4<sup>th</sup> May 2023 at 8.30am, a huge contingent of Armed radical/ Meitei, Arambai Tengol and Meitei Iepun attack our village and in the process looted/Vandalized and burnt our houses and properties.

3. That the above said criminals with their inhumane activities have caused me grave mental agony. Notwithstanding the fact that, these unruly activities have made me great loss enormous wealth estimated to be Rs 12 lakhs 50k

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Tuibuong S. Canan veng, Churachandpur.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
