Subject :- Report on Looting of household items/assets, and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Paokholun Chongloi aged about 62 years S/o (L) L Tonglal Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident of Langol Spring Villa Joseph Colony Phaipijang ,Imphal-West District Manipur. P.O. &P.S., Lamphel.
- 2. That at about 10 am on the 4th May 2023, due to the ethnic violence in the state Our locality at the above mentioned address was attacked by Meitei radical groups suspected to be a members of Arambai Tengol and a Meitei mob. So, in order to save ourself, I and my Family have to run for our lives leaving behind our House , along with all our household items and belongings, and took shelter at CRPF Camp Lamphel and in the process, some unknown miscreants have looted our house including all our household items.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.30,00,000 (Rupees Thirty Lakhs) only
- 4. Fortunately, I managed to escape from the Violence, and now currently taking refuge Kanan Veng Tuibong Village Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
