Sir,

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Vungngaihhau aged about 49 years W/o (L) S Kamlianpau Belonging to the Paite Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident of National Games Village Zone-III, Near Mary Kom Complex, Imphal-West District Manipur. P.O. &P.S., Lamphel.
- 2. That at about 3;30 am on the 4th of May 2023, due to the ethnic violence in the state I and my Family have to run for our lives leaving behind our Rented House owned by Pumjamang Shoute at the above mentioned address, along with all our belongings and too shelter at CRPF Camp Lamphel and in the process, some unknown miscreants have looted our house including all our household items and some of our .Domesticated animals (5 Dogs , 1 Cat and 5 Ducks) and also a brand new Two wheeler N Torque (Green and Black stripes).
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.35,00,000 /- (Rupees Thirty Five Lakhs) only
- 4. Fortunately, I managed to escape from the Violence, and now currently taking refuge Kanaan Veng New Lamka Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
