Subject :- Report on demolition of Building and looting of demolished items and discrimination of Scheduled Tribes

Sir

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Vunglunkim Guite aged about 24 years d/o (L) Vungzakam Guite belonging to the Paite Tribe/Community, a scheduled Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under the The ST/SC (Prevention of Atrocities) Act, 1989, and that I am a resident of Langol Game Village Zone II, Imphal West, PO & PS Lamphel.
2. That at about 8 am on the 4<sup>th</sup> May 2023, due to the ethnic violence in the state I and my family have to run for our lives leaving our Quarter along with all our belongings. All our belongings have been looted by unknown miscreants for which a separate FIR has been lodged at Shillong (Nongmensong) .
3. That I have a private plot near National Game village and my building is under construction. Since it was not possible to contact people at Imphal so easily, it was not possible to obtain any information about the condition of my house for the past many months. However recently I am in a position to obtain photographs of my building and it is observed that all the aluminium windows and the profile sheet roofing have been dismantled and looted.
4. That, it may be reported that here that the above said criminal activities have caused mental agony and incurred huge loss which may be estimated to be Rs.5,00,000 (Rupees Five lakh) only.
5. Fortunately, I managed to escape from the violence and now currently taking refuge at Nehru Marg, Churachandpur.
6. That, I am filing this information lately because there is great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
