

Subject: Report on crimes of unlawful displacement, attempt to murder, looting & vandalism of personal belongings including Original Documents and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Simte Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Pamzal Village, Thalon sub-div., P.O. & P.S- Thanlon & district- Churachandpur, Manipur.

That, due to the prevailing crisis in the State of Manipur between the majority Meetei/ Meitei and the minority Kuki-Zo which erupted on the 3rd of May, 2023, our resident located at TATA Motors, Changanggei, Ucheckon, Awang Leikai, P.O. & P.S.- Lamphelpat, district- Imphal West was robbed by a mob of criminals belonging to the Meetei/ Meitei community, in the process they have looted and vandalized our **personal belongings/ movable assets including all my Original Documents**, at around 6:30 PM on the 3rd of May, 2023, while we were hiding near the vicinity.

That, on the 4th of May, 2023 at round 10:30 AM, in order to save ourselves from the Meetei/ Meitei warmongers, while heading to the Imphal International Airport, we were stopped near the Exit Gate of the above mentioned Airport by a mob of criminals and on knowing that we belong to the Kuki-Zo community, they planned to torture and murder us, yet somehow we managed to save ourselves by escaping from the said mob.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.8,47,000/- (Rupees Eight Lakhs Forty-Seven Thousand) Only, inclusive of **my personal belongings along with my Original Documents**.

The reason behind my late application is due to which I was at remote areas working as an assistant truck driver for months. Therefore, I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
