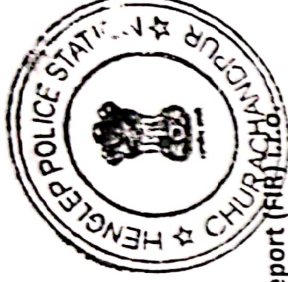

Subject:-Lodging of First Information Report (FIR) LTO.

- i) Robbery of residence of PAOKHOLUN HAO KIP, aged 75 years, S/o (L) THANGIALET HAO KIP at MICHAEL HOUSE, Hebron Veng, Opposite Type-2 Parking, Langol, Imphal West, Manipur.
- ii) Burning down of above mentioned house & vehicles

Sir,

I would like to put the following points for your kind consideration.

- a) That, due to the recent ethnic clash between Kukis and Meiteis in Manipur, the Kukis have left their homes in Imphal valley and fled for their lives to the hill districts and other states.
- b) That, the vacated residence of PAOKHOLUN HAO KIP(a Kuki)S/o (L) THANGIALET HAO KIP at MICHAEL HOUSE, Hebron Veng, Opposite Type-2 Parking, Langol, Imphal West, Manipur, PIN-795004 was robbed of everything from 17th May 2023 till 19th May, 2023 as per a reliable source from the locality. As per the source, people residing in the nearby neighborhood were involved in the burglary.

4) That, Three houses (2 Semi-Pucca houses & one 3-storeyed Building) located inside our compound were burned/destroyed on the intervening evening of 5th August, 2023 by Meitei mobs.

6) Also, Certificate of registration and other documents and files of the Sita Women Development Association (Society registered under the Manipur Societies Registration Act) were also abandoned.

Therefore, I request you to kindly acknowledge the above report and register an FIR in respect of the above mentioned robbery, vandalism & burning of properties to initiate necessary actions for arrest of the culprits and recover the stolen properties. FIR could not be lodged in concerned Police Station (Lamphel PS) due to displacement by the ethnic clashes.
