Sir,

I have the honour to report that on 4/5/2023 at about 5 pm, my family had escaped to old Sangaiprou Kabul Khul for safety as news were learnt about attack on Kuki-Zo people in Imphal City. I am a resident of Kom Colony Sanagaiprou, PS Lamphel, Imphal West District and I am serving in 4<sup>th</sup> Assam Regiment as Indian Army no.4375706N.

In that, my Residential house at Kom colony Sangaiprou, Imphal West District, was attacked by Meitei miscreants suspected to be personnel of Arambai Tengol and Meitei Lepun along with local people at around 6 pm of 4/5/2023. In the process, the said miscreants vandalized and looted and burnt down all my properties. The total estimated to be loss is about 15 lakhs approximately.

. It is, therefore, requested to kindly register FIR against the said miscreants, as per law of the land.

Cause of delay in reporting on time is due to my displacement.
