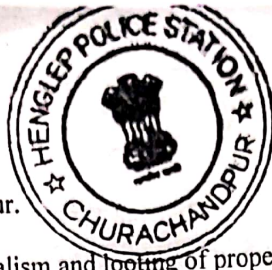

Subject: Report regarding vandalism and looting of properties.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I would like to inform that due to the communal clash that broke out from 3rd May, 2023, we had abandoned our government quarter No. G-12, Langol Housing Complex, Imphal West District, Manipur, for our safety and get evacuated to a safer place.

However, on 12th June, 2023, we had received information from our neighbours that on the same day at around 5:00 p.m, my residential Quarter, mentioned above, was broke opened by unknown miscreants and all my household properties Rs. 5,70,000/- including my original educational certificates (from Class - X to Graduation) and other important documents were vandalized and stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
