However, on 12th June, 2023, we had received information from our neighbours that on the same day at around 5:00 p.m, my residential Quarter, mentioned above, was broke opened by unknown miscreants and all my household properties Rs. 5,70,000/- including my original educational certificates (from Class - X to Graduation) and other important documents were vandalized and stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
