Subject: Lodging an FIR regarding.

Sir,

With due respect, I the undersigned would like to put few words that my residential quarter i.e., Qtr.No.Type-III/G-2 Lanogl Housing Complex, Imphal West has been ransacked and vandalsized by unknown miscreants suspected to be Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup and other extremist volunteers comprising about 300 people by holding deadly weapons on the 4th and 5th May, 2023 around 11 PM.

The miscreants have looted all my household properties such as TV sets, Laptop, Washing machine, Refrigerator, sofa set, dining sets, Almirah, four Gas cylinders and stove, Kitchen items, blankets, dressing clothes, garments and syntax.

The total value of vandalized, looted and stolen properties is estimated to be Rs. 23,00000/- (Twenty Three lakhs) approximately.

I could not report the incident to my concern Police Station as well as on time due to prevailing law and order situation in the state.

Therefore, I request your good office to kindly take necessary action in this regard.
