As per the Government order no. 1/26/2013-EST (W):2 dated 27th February, 2024 quarter No type V/CP-2 Lamphel was alloted to Nectar Sanjenbam, Sr. S.P-COMBAT, Police Department.

Thereafter I along with my husband's escort team visited the quarter on 28th Feb, 2024, Lamphel and found the quarter to be in good condition. However, it was found to be occupied by a lady namely Takhellambam Kiranmala Devi (28) yrs D/o. T. Shamu Singh of Thoubal Wangmataba under Thoubal District and one Mr. Gojen and also Havildar Prem who is presently attached in CID, Police Department. On enquiry the lady claimed to be working in Sericulture Department as a Stenographer as per the Aadhar xerox enclosed. They were told to vacate the quarter by 15th March, 2024 as the quarter has been alloted to Nectar Sanjenbam, Sr. S.P- COMBAT who is now posted a Moreh for maintaining law and order.

On 13th March, 2024 the escort team visited the quarter again to see if it has been vacated but it was not so. Then on 14th March, a call came from Gojen (mobile No. 9774436685) that the quarter had been vacated. We immediately at about 2:00 p.m., went to the quarter and found the following damages by the illegal occupants.

- 1. All the electric wires, switch boxes, lights and fans were missing.
- 2. The water connection pipes were destroyed.
- 3. The kitchen counter and sink were removed.
- 4. All the taps, wash basins, commodes and accessories were missing both from the bathroom and
- 5. Some of the doors were also removed.
- 6. The water tank was missing.
- 7. A shed had been removed.

So, I therefore request you to kindly take necessary legal action against for destruction Government properties.
