With due regards, I undersigned have the honor to state a few lines for your kind consideration and needful action.

That, my residential house which is located at Hill Side Colony, Langol besides a Football Turf Ground has been looted and all the household articles have been completely stolen on two different occasion by unknown miscreants. The first incident happened on the intervening night of date 11 and 12 Feb, 2024 and the second incident on the intervening night of 23rd and 24th March, 2024. I had been staying since the construction days of my house and had left the house for my wife's treatment at Chennai during February, 2024. Even the doors of my house have been dislocated and plucked out.
