Subject: - Report.

Sir,

I have the honour to state that today i.e. 31/03/2024 at about 01:00 am received a reliable information that some armed miscreants of SALAIEN MAPARI KDF (KDF-Kangleipak Defence Force) have been carrying out prejudicial activities such as extortion, kidnapping and training of new recruits under the leadership of one George @ Lalloiba of SALAIEN MAPARI KDF organisation at Lamphel near Kombirei Housing Complex, KV road. Based on the information, a combine team of CDO-IW, Lamphel-PS led by Shri Okramcha Wangkhomba, MPS, Addl. SP (LO-IW) and assisted by Shri N. Ingocha Singh, MPS, SDPO-Lamphel, Shri T. Bimolechand Singh, MPS, SDPO-Mayang Imphal, Inspector Anilchandra Mutum of CDO-IW, Inspector Khogendro Pangambam, OC-Lamphel PS, a column of 4 AR and myself were immediately formed and the said combine team under the supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW and under the overall supervision of Shri Themthing Ngashangva, IPS, IG Zone-I launched a search operation to nab the armed miscreants at the above-mentioned area.

During the operation, at around 2:00 am while the combined team along with a requisitioned Executive Magistrate, IW (Central)-1 Manipur reached at Lamphel near Kombirei Housing Complex, KV road one unknown person was detained along with one Himalayan Royal Enfield motorcycle bearing regd. no. MN01AJ 1504 on the approach road of KV Lamphel near the gate of IDTA Lawn Tennis court Complex due to his suspicious nature. During spot verification, he identified himself as Moirangthem Lanchenba Meetei (18 yrs.) S/o. M. Ibochouba of Sagolband Tera Moirang Hanuba Mamang Leirak. On spot checking, one Redmi Note11 Pro model no. 2201116TI along with one Jio SIM card bearing no. 89918650400205693916 (Ph. no. 8258082988 as disclosed by him) was recovered from his possession. On preliminary verification, he disclosed that he is an active member of SALAIEN MAPARI KDF organisation and joined the said organisation in March, 2024 through one Wilson from Sagolband Moirang Hanuba Leirak of SALAIEN MAPARI KDF organisation and presently working under the command of one s/s Commander Kaliya from Lamphel of the said organisation and one s/s Chairman George @ Lalloiba of the said organisation. He further disclosed that under the instruction of his commanders he was recently involved in extortion activities related to the monetary demands from drug smugglers of North AOC and Kshetrigao area. He further disclosed that their members are sheltering at a camp inside a compound located near the Imphal Football Academy, Lamphel. Hence, he was arrested at 2:20 am from the spot by observing formalities and the recovered item along with the above-mentioned Himalayan Royal Enfield motorcycle were seized at 2:30 am by observing formalities in presence of the witnesses.

Based on his disclosure, the combined team immediately rushed to the disclosed camp area located near the Imphal Football Academy, Lamphel and surrounded and cordoned the said camp area and conducted search operation. During that one unknown person was detained who later identified himself as Mayengbam Yaikhomba Singh (14 yrs.) S/o. (L) M. Mangal Singh of Lamjao, Wabagai a/p Kakwa Naorem Leikai Lairembi Maning, Canchipur. On spot body search, 1(one) Redmi Note10 Pro mobile handset model no. M2101K6P along with one Vodafone SIM card bearing no. 8991755261071811563 SY (Ph. no. 7641017322 as disclosed by him) was recovered from his possession. On spot verification, he disclosed that around 9-10 nos. of his associates ran away from the camp while the police team approaching their camp. Immediately, the combine team tried to chase them but due to darkness they were not found.

On further searching the said camp, the following items were recovered:

- i. One .32 pistol marked as " 32. PISTOL " along with one magazine.
- ii. One 9mm pistol marked as "IMN Company 131115 " along with one magazine loaded with 4 (four) nos. of 9mm ammunition.
- iii. One SBBL gun marked as " Stallion PRO PX-701-AS " mounted with one telescope.

- iv. One Chinese hand grenade.
- v. One Redmi mobile handset without SIM card.
- vi. One ASUS mobile handset model no. ASUS_X00TD along with two Jio SIM cards bearing nos. (i) 89918650400114118252 and (ii) 89918650400133000168.
- vii. One itel mobile handset model no. it2171 along with one Airtel SIM card bearing no. 0222 ID 8991160990018019187U.
- viii. Three nos. of BAOFENG handheld wireless sets along with two chargers.
- ix. Two nos. of UV-10R handheld wireless sets.
- x. One round seal of SALAIEN MAPARI KDF.
- xi. One blue flag of SALAIEN MAPARI KDF.
- xii. One camouflage jacket.
- xiii. One BP black vest.
- xiv. One camouflage cap.
- xv. One camouflage full shirt.
- xvi. One camouflage long pant.
- xvii. Eight nos. of letter heads of SALAIEN MAPARI KANGLEIPAK DEFENCE FORCE signed by Chairman H. Lalloiba and President O. Meitei.
- xviii. Eight nos. of letter heads of SALAIEN MAPARI KANGLEIPAK DEFENCE FORCE signed by President O. Meitei.

Further on searching the said camp area, (i) One EECO Van silver in colour without registration number was also found parked which was suspected to have been used by the members of SALAIEN MAPARI KDF organisation.

On preliminary verification, Mayengbam Yaikhomba Singh disclosed that he is an active member of SALAIEN MAPARI KDF organisation and joined the said organisation in March, 2024 through one s/s Chairman George @ Lalloiba of the said organisation and presently working under the command of one s/s Commander Kaliya from Lamphel of the said organisation and s/s Chairman George @ Lalloiba of the said organisation. He further disclosed that the above recovered items and vehicle are used by the members of the said organisation i.e., SALAIEN MAPARI KDF organisation. Hence, he was apprehended at 3:10 am from the spot by observing formalities and the above recovered arms and ammunitions, vehicle and other items were seized at 3:20 am by observing formalities in presence of the witnesses.

Hence, the apprehended CCL and the arrested person along with the seized items are handed over to you for taking further necessary legal action against them.
