- 1. That, on 7/5/2023 at around 4:55 pm. Some unknown miscreants suspected to be Kuki Tribes, Kuki militants stormed our locality with Arm and other incriminating weapon. They have looted and vandalized my house and Cattles/Poultry/Household items/furniture/Electrical equipment's/Food items along with other items at Kwatha Khunou.
- 2. That, the value of loss/damaged properties is around Rs. 22,47,430/- the details of the items are given below:
- a) Vandalized my house valued about Rs. 6,00,000/-
- **b)** Damage Dragon Fruit tree farm having about 801 nos. Rs. 200x708 =Rs. 1,60,200/-
- c) Lemon tree 708 nos. Rs. 60x708= Rs. 42,480/-
- d) Avocado tree 50 nos. Rs. 250x50= Rs. 12,500/-
- e) Bean tree (yongchak) with fruit 50 nos. Rs. 12,000x50= Rs. 6,00,000/-
- f) Apple tree 30 nos. Rs. 120x30= R. 3,600/-
