It is to Inform you that on 3rd and 4th of May 2023, a violence erupted between the "Meiteis and the Kukis" at Imphal. And fearing upon our lives, we ran to the closest CRPF camp at Mantipukhri for our safety and security reasons. And from there on, we move away to a safe place which is outside of Manipur and settled there for more than 7 months.

And recently, we have been informed on 15 December 2023 at around 3:00 PM that a number of Meeitei goons who are suspected to be Arambai Tenggol and Meitei/Meeitei Leepun went and attacked my residence at Langol Housing Complex, Quarter no. E-III-26, at Imphal-West District. They have also looted all of my household properties and vandalized my belongings, worth more than Rs. 80,00,000/-(Eighty Lakhs).

Therefore, I hereby request you to lodge an FIR in connection with this incident at the earliest.
