With due respect I would like to state that on 4th May, 2023 at around 4:00 pm our locality National Games village under Lamphel Police Station, Imphal West District was under attacked by Meitei mobs with an intention to murder us and caused destruction of our properties. Religious place and Private residence of Kuki were attacked. Then, we suddenly left our properties and house on the same day since it was not safety for our life. So, our residential house has been left unattended till today. However, I came to learnt that, my house was intruded by unknown miscreants and destroyed/looted all my household properties in between 10th & 20th October, 2023.
