That, following May 04<sup>th</sup> 2023 incident fearing lost of life we abandoned our plot (land) and we fled to CRPF, Lamphel, and later to Kangpokpi District, Manipur.

With the unstability law and order situation and intense communal tension in the state, it is not possible to construct the house at the said plot (land).

Due to lack of legal knowledge I could not report to the concern authority in time.

It, is therefore, requested you to register a FIR for necessary action.
