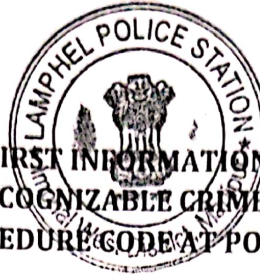

Subject: Report for FIR on Looted/Vandalized/Burnt/Stolen Properties

Sir,

With reference to the above cited subject, I have the honour to report to you as below:

1. That, I, Joseph Lalditsak age 37 s/o (L) Fimzathang belong to the Hmar tribe, a Schedule Tribe recognized under the constitution of India. By virtue of which I am entitled for protection under the SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I had been working as an attendant at RIMS Hospital, Imphal on contract basis since 2008 and living at RIMS Quarter Type-III, Imphal.
2. Due to the ethnic clash in Manipur, I have left my quarter on 4th May 2023 for the safety of my life and take refuge at CRPF Camp, Lamphelpat, Imphal and on 8th May 2023, with the help of the central forces I could manage to reach Delhi by flight. That, on 6th May 2023 a group of **Radical Meitei/Meitei Mobs**, suspected to be **Arambai Tengols and Meitei Leepun** attacked the said quarter and in the process looted/vandalized/burnt/stole all my household properties which were inside my quarter, including my vehicle.
3. That, the above said Criminals with their in humane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be **Rs. 25 lakhs** only.
4. Fortunately, me and my brother narrowly escaped from Imphal on 8th May, 2023, I was so scared of the events that engulfed me while I stayed at CRPF Camp, that, I even fainted at the Airport. From then on I began to feel sick even after reaching Delhi for a long time. I underwent bed rest for the remaining part of the year as I was weak and could not even had a sound mind.

Due to my poor health I stayed at Delhi for a long time, and beside the prevailing law and order situation, I was unable to returned to Manipur soon and thus, I could not submit FIR in time. I therefore, request you to register an FIR/Zero FIR and bring justice. Currently I am living at my native village, Damdiei, Pherzawl District, Manipur.
