

That, I, Tingcha Chongloi wife of (L) Jiten Chongloi and my family reside there. Following 3 May 2023 violence in Imphal valley we all were evacuated from Imphal leaving behind all th household items. Till 12 December 2023 sources informed that it was safe.

However, from a reliable telephone source received on 10th Jan. 2024, some unknown miscrean in collusion with one Naobi (Owner of the house) have vandalised my rented house and looted all th moveable and valuable items including all the household items worth about 22 Lakhs as per ow

The incident is suspected to have occured on the 2nd January 2024.

The list of properties loss or damaged are mentioned in the annexure (enclosed).

'It is, therefore, requested to kindly register a regular case and take necessary legal action again the culprits according to law.
